4.1 Approval of Minutes – June 5, 2023

4.2 Process to Monitor Legislation - DISCUSSION

Legislative Committee reviewed avenues of monitoring legislation related to the Contra Costa County Office of Education which would help the committee build a monitoring process. The committee reviewed updated legislative monitoring resources and requested that it be posted on the agency's website.

4.3 SB 739 Update

Neil McChesney, Coordinator, Charter School Oversight, presented to the Legislative Committee an update on Senate Bill 739 – School Accountability: charter schools: term of operation. The bill was included in the budget trailer bill, the expansion omnibus bill, and is now Senate Bill 114 and is now awaiting the Governor to sign it. With this signing, charter renewal processes will be pushed back a year.

4.4 SB 413 Update

The Legislative Committee reviewed Senate Bill 413 – School attendance: interdistrict attendance. The bill refers to the time period mandated for County Offices of Education to make a decision on interdistrict transfer appeals which is currently 30 days. If the bill passes, that time will be extended to 45 days.

4.5 AB 1023 Update

The Legislative Committee reviewed Assembly Bill 1023 – California Cybersecurity Integration Center: school cybersecurity. The current makeup of the California Cybersecurity Integration Center includes 16 different state entities and at least one representative from 60 different community colleges and California University systems. School districts are not represented and this bill aims to change that to help districts combat cyberattacks which are on the rise at school districts.
