8.3 Evaluation of Legal Services (CLARK) - ACTION

Mary Ann Mason, Assistant County Counsel, explained the questions before the Board are 1) whether the establishment of the Golden Gate Charter School MOU is appropriate and involves the statutory authority of the County Board, and 2) whether or not the majority of the Board believes there may exist a potential of conflict of interest by using Dannis Woliver Kelly (DWK) to answer questions because they are designated as legal counsel for charter school matters.

Ms. Deane said she would like to know the cost of looking at other firms before making a decision. Ms. Belle said that he would like to look at other law firms. Ms. Chavez stated she would rather see the funds used to improve schools. Mr. Maxwell stated he has been pleased with DWK. President Alleyne said she thinks it would be helpful to have the Board speak with counsel regarding the MOU. She expressed concern that a precedent could be set for other charter schools to start charging districts for special education services.
