# 8.1 Labor Agreement Proposals - CCCSEA and PEU (COTTON) - INFORMATION

# 9.1 Overview of the Contra Costa County Office of Education Teacher Induction Program (TOKUYOSHI) – INFORMATION

Marsha Tokuyoshi, Senior Director, Educational Services, introduced Nyere DaSilva and Charise DeCoito, Coordinators, Teacher Induction Program. The Contra Costa County Office of Education (CCCOE) Teacher Induction Program (TIP) is accredited by the California Commission on Teacher Credentialing. They are a consortium of local school districts, charter and private schools within the surrounding bay area counties. Teacher Induction is a two-year job embedded program where participating teachers meet weekly with an experienced mentor to create an Individualized Learning Plan (ILP) using the California Standards for the Teaching Profession (CSTP) that aligns with local goals and expectations. Upon completion of the CCCOE Teacher Induction Program and verification of all requirements, participating teachers are recommended for a California Clear Teaching Credential.

Board Members asked questions regarding mentor retention, program reach and participant cost.

# 9.2 Consider Action to Either Approve or Deny the Petition to Renew the Contra Costa School of Performing Arts (SPA) Charter and Adopt a Resolution (CLARK) – ACTION

Bill Clark, Deputy Superintendent, introduced Neil McChesney, Executive Director, School of Performing Arts. Mr. McChesney presented the Board with a PowerPoint presentation outlining CoCo SPA's Finding of Facts, Board Member questions from October 21, 2020 Public Hearing and reviewed information provided in their renewal

CCCOE asked the Board to approve the list of school district Supervisors of Attendance who have been certified.
